

#### Earz: PRIVACY POLICY

## This Policy was last reviewed and updated on 07/02/2025

Earz Pty Ltd (ABN 65 672 816 929) ("us", "our" and "we") collects and is committed to protecting your privacy and complying with the Privacy Act 1988 (Cth) ("Privacy Act") and other applicable privacy laws and regulations in Australia. This Privacy Policy sets out how we collect, hold, use and disclose your personal information, and how we maintain the quality and security of your personal information.

#### What is Personal Information?

To help us provide the best possible customer service, we may collect the following "Personal Information" from you:

- a. your name, date of birth and contact details, including your address, phone number, email address and serial number of a device;
- b. health fund details, Medicare number and relevant information from government agencies (such as Centrelink, Department of Veterans Affairs, Ministry of Health and/or the Accident Compensation Corporation);
- c. health and welfare information, including past and present health conditions, hearing test results, diagnostic images of the ear and any other audiological records, prescribed medication, hearing prescriptions and any other health information provided by you or your healthcare provider;
- d. information about your circumstances including employment status and history, cultural and linguistic background, and family circumstances;
- e. information about your family and other related persons such as partners, children and carers;
- f. information about your visit to our website; information provided in forms you fill in on our website, and any other information you have voluntarily provided to us; and
- g. any information we are required to collect as part of our legal and regulatory obligations, including without limitation, information under the Health Practitioner Regulation National Laws as enacted in each state and territory of Australia and the Hearing Services Program (Voucher) Instrument 2019.

Some Personal Information we collect is "Sensitive Information" which may include information or an opinion about your hearing and health condition and history. We collect Sensitive Information to provide health services to you. We will only use the information disclosed for the purpose for which it was provided.

### Collection of Personal Information

We collect, store and use your Personal Information to provide you with the services you elect to receive from us and for the other purposes set out in this Policy. We may collect this Personal Information from you in various ways, including:

- a. through a website or application that is owned or operated by us;
- b. through e-mail and other online tools and applications;
- c. through our online portal which contains several hearing related tests ("Online Tests");
- d. through one of our stores/ clinics when you visit, or make an enquiry over the phone for a hearing test, or other service, or purchase or enquire about our products;
- e. through information provided by you if you apply for a job with us;
- f. through our customer feedback surveys;
- g. through our social media accounts;
- h. through third parties such as an authorised person who may provide your personal information to us, employment recruitment agencies, health insurers or Government agencies, and audiology professionals and health practitioners (with your consent or to the extent permitted by law).

Please note that the information or services provided by us are directed at those over the age of 16. We do not knowingly collect Personal Information from anyone under the age of 16. If you learn that your child has provided us with Personal Information without your consent, please alert us as soon as possible.

### How do we use your Personal Information?

We may use your Personal Information only as described in this Privacy Policy, such as to provide you with our services, products and information; to conduct certain analyses and statistics, such as to improve our products and services; and to the extent permitted or required by applicable laws, or in support of any legal or criminal investigation.

We may disclose an anonymised version of your contact details (to protect your details) to third parties (such as social media providers) to collect statistics to help us improve our products and services (for example, to monitor how effective our targeting advertising is). This information would have undergone an appropriate and robust de-identification process to protect your identity.

# With whom do we share your Personal Information?

We may disclose your personal information to third parties for the purposes set out in this Privacy Policy.

We may disclose your personal information to:

- a. medical and health care providers involved in the provision of health services to you;
- b. health insurers, health authorities and regulators as permitted or required by law;
- c. our suppliers (who are located overseas in the USA, Switzerland, Vietnam and China but may be located elsewhere from time to time) if you order a product from us;

d. to government authorities in relation to government programs, such as the Hearing Services Program.

Please note that our affiliates and subsidiaries, as well as authorities, customers and suppliers to whom we may disclose your Personal Information, may be located in a different country, (such as the United States), whose data protection laws may differ from those in Australia. In such cases, we will ensure that appropriate safeguards are in place to protect your Personal Information.

In some instances, we may additionally ask for and will need your specific consent for collecting and using your Personal Information, especially in connection with sending you marketing materials or newsletters regarding additional products and services we think you might be interested in.

### If you refuse to grant us consent to collect and use your Personal Information

If you do not provide the personal information requested:

- a. we may not be able to provide you with our services or products;
- b. the quality of the services or products provided to you may be lesser than if you had provided all of the information requested; and
- c. the risk of adverse consequences from our provision of services and goods may be increased. We are not liable to you for any adverse consequences resulting from your failure to provide accurate personal and health information.

# Direct marketing

We will occasionally communicate with you by mail, telephone or electronic means to offer you products or services that may be of interest to you. You may withdraw your consent to be contacted at any time as long as you give us reasonable notice of withdrawal. #### Research

Earz is committed to contributing to continuously improving understanding of hearing healthcare and hearing aids, and improving our products and services. To this end, Earz performs internal research and is involved in research with universities and other third-party organisations or individuals (Research Organisations). Information related to you (but always fully de-identified) may be used by Earz for these purposes.

This research involves the collation and analysis of (de-identified and non-personal) data collected from our clinics, centres and online (including our online portal). For example, this may include data collected during assessments performed by our clinical staff or from your participation in Online Tests. The research may be presented in journals, conferences, patents or other publications.

Earz only discloses such de-identified and non-personal data to Research Organisations or in publications. You will not be able to be identified from that data. We and the Research Organisations are bound by confidentiality and privacy laws.

Our contracts with Research Organisations contain legally binding provisions to protect your privacy.

# How do we protect your Personal Information?

We handle all your Personal Information with the utmost care.

We have implemented a variety of security measures to protect your Personal Information from unauthorised access, use and disclosure. These follow technical and organisational measures generally accepted as appropriate security standards in the industry, including access controls, password, encryption and regular security assessments.

Although we take reasonable steps to maintain the security of our internet connections and safeguard your personal information, for reasons outside of our control, information transmitted to us over the internet may not be absolutely secure. We assume no responsibility for disclosure of data due to errors in transmission.

We ensure that all employees and contractors are bound to keep your Personal Information confidential and to not use or disclose your personal information in a manner contrary to this Privacy Policy.

## How may you access control or delete your Personal Information?

You have the right to request access to, and correction or deletion of your Personal Information.

## **Cookies and Usage Tracking**
